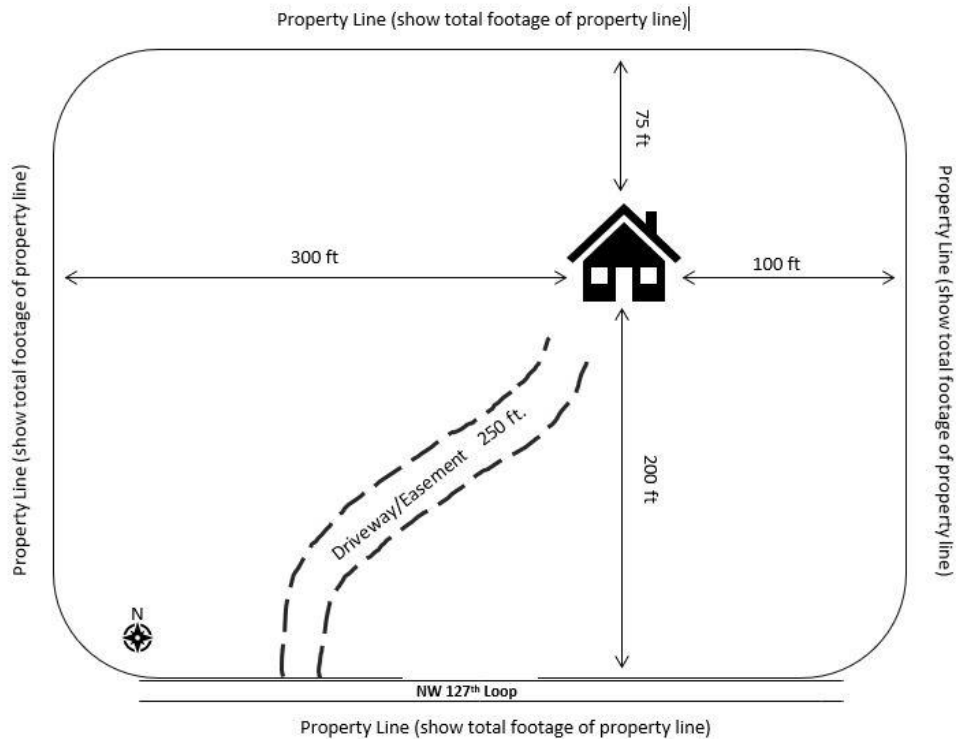

**NOTE: Assignment of address does not guarantee permit approval. You still need to see the Building Department for permits.**

NOTE: Site Plan does **NOT** have to be on the survey, but the dimensions and measurements need to be accurate. **We do not address parcels; we address only occupied structures!** The Health Department Site Plan can also be used, you will need to just add the dimensions to it.

1. Proof of ownership (warranty deed, quick claim deed, etc)
2. A survey/plat plan or drawing showing the property lines of the parcel.
3. Location of planned resident or business structure within the property showing where the front door is **and the distances/footage from EACH property line** (if property is a large parcel, we will need the dimensions from **EACH** property line) to the structure. If the property has been split from a larger property, we will need to see the split on a survey and then the site plan within the newly split parcel. See sample below.
4. Location of the access point (driveway, easement, etc.) Please show how the driveway / easement is coming from the main road. Show the total footage of the driveway / easement.
